

UNRSF Project on “Reducing Road deaths and injuries in Jordan through increasing restraint use”

Final Workshop

Amman, Jordan
13 February 2025

- **Background:**

Within the framework of the UNRSF project, a first national workshop was held under the patronage of the Ministry of Interior on October 12, 2021 to discuss the project activities, the implementation plans, and to engage all related stakeholders to advice on the project's programs.

On September 15, 2022, a second national workshop was held under the patronage of the HE Minister of Interior; the workshop was dedicated to present a revised draft on seat belt and child restraint regulatory framework by the project experts, as well as to improve road safety in Jordan by increasing the use of seat belts and child protection seats.

The third national workshop on March 16, 2023, under the patronage of His Excellency the Minister of Interior, focused on the implementation of the remaining activities of the project in Jordan. In particular, the seatbelt and child restraint awareness and enforcement campaigns with illustrations from the experiences of the developed countries in the road safety field, and the training of trainers course in collaboration with the Public Security Directorate were presented and discussed.

The final workshop, scheduled on 13 February 2025, aims to engage various traffic safety-related stakeholders and invite them to discuss the project's activities and achievements.

In particular, the final workshop will present and discuss:

- the revised draft on seat belt and child restraint regulatory framework by increasing the use of seat belts and child protection seats.
- how the project revised regulatory framework contributed in the revision of the modified traffic law.
- the training of trainers course to prepare specialized trainers from the Public Security Directorate
- the awareness campaign
- the pre and post observational survey, their results and the related reports

Additionally, the final workshop will present and discuss the final report prepared by an external

consultant.

Finally, participants and stakeholders will build on the achievements accomplished by this project to sustainably reduce road crash fatalities and serious injuries in Jordan thereby achieving target 3.6 of the SDGs, ie reduce the number of deaths and injuries from road traffic accidents in Jordan by 2030.

Expected outcomes:

- Stakeholders feedback on the projects reports and achievements.
- A draft roadmap for the proposed activities and efforts to pursue the **sustainable reduction of road crash fatalities and serious injuries in Jordan**.

- Generated reports and official letters as a result of the workshop
